

***Tips on Making a RA7ALL – a Representation Agreement with all four authorities
from section 7 of the BC Representation Agreement Act
The authorities correspond to the 4 life areas - see chart on p. 2.***

Do NOT send any RA paperwork to Nidus by regular mail or by email – it will be shredded or deleted.

What makes the RA Act of BC world renowned?

It allows someone with **cognitive difficulties** to make a legal document (a Representation Agreement) with authorities from section 7. This is a first in the world.

Do you have the right package?

This material is about the RA7ALL. The RA7ALL form is free - see link at bottom of next page. For other types of Representation Agreements, go to <https://nidus.ca/ra-forms/> and scroll down.

RA7 is sometimes used as a generic term. Nidus uses more specific terms (and has different RA7 forms).

- RA7ALL has **all 4** authorities as shown in graphic on next page:
 1. Minor and major **Health care** matters,
 2. **Personal care** matters,
 3. Obtain **Legal** services and instruct counsel..., and
 4. Routine management of **Financial** affairs.
- RA7H+P has two authorities (minor and major health care matters and personal care matters);
- RA7F+L has two authorities (legal matters and routine management of financial affairs).

WHO MAKES THE RA7ALL?

No one has automatic authority to act on behalf of an adult (not parents or even a spouse).

- You must be **19 years or older** (an adult) to make the RA7ALL. (19 is the age of adulthood in BC).
- The RA7ALL was specially designed for adults with cognitive difficulties.
- It all depends on CAPABILITY requirements.
 - It is common for a spouse with advanced dementia to make the RA7ALL and the other spouse to make the RA9 + Enduring Power of Attorney.
 - The same for a parent with an adult child with a developmental disability. The adult child with a disability may make the RA7ALL and the parent(s) make the RA9 + Enduring Power of Attorney.

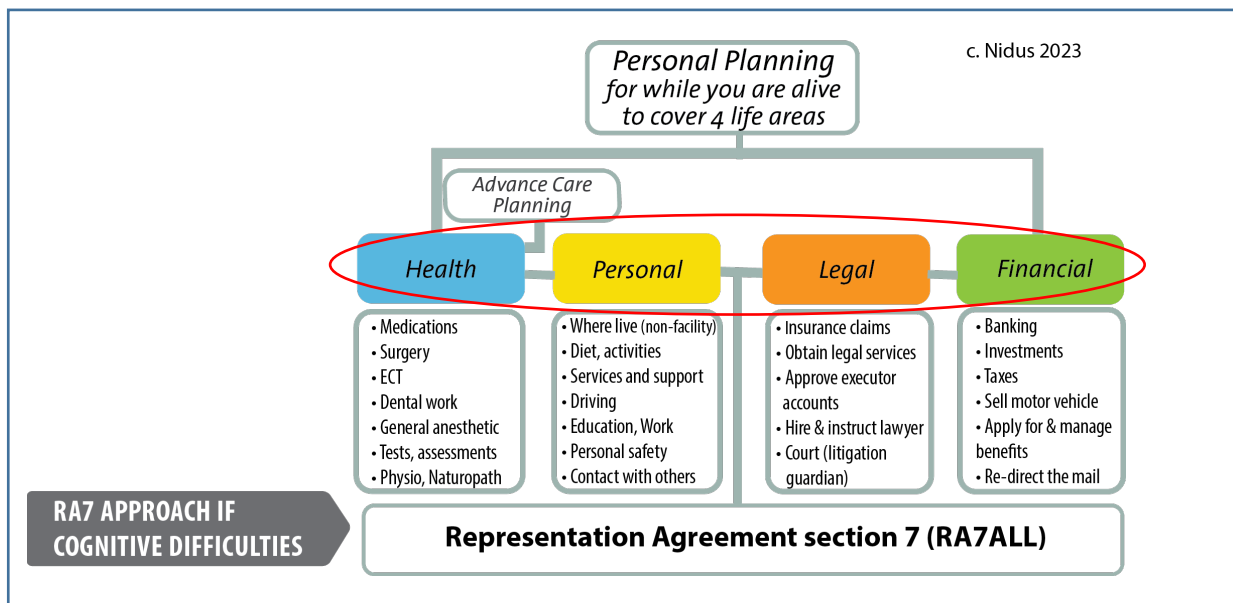
ARE YOU IN THE RIGHT FRAME OF MIND?

If you are thinking the RA7ALL gives you total control over the adult – you are wrong.

Values, terminology and approaches change and evolve. New thinking applies to adults in the community living sector as well as to other adults who get dementia or have a serious stroke.

When supporting an adult with a disability, you may need to change your language and your thinking. Even if an adult has many disabilities and needs lots of help, the adult is a PERSON and has the same rights as any adult. The RA7 is about helping these adults to exercise their rights.

Even if you type, you must print hardcopy to get original signatures and handwrite some dates. Scan the completed hardcopy in PDF format for uploading to the Nidus Registry.

A medical assessment is NOT required for making any type of RA. A legal professional is NOT required.
