

Making an RA7ALL – a Representation Agreement (RA) with all four authorities from section 7 of the BC Representation Agreement Act (RA Act).

Do not send any paperwork to Nidus by mail or email unless directly requested by us - it will be shredded or deleted. If you want to register your completed legal document, go to nidusregistry.ca

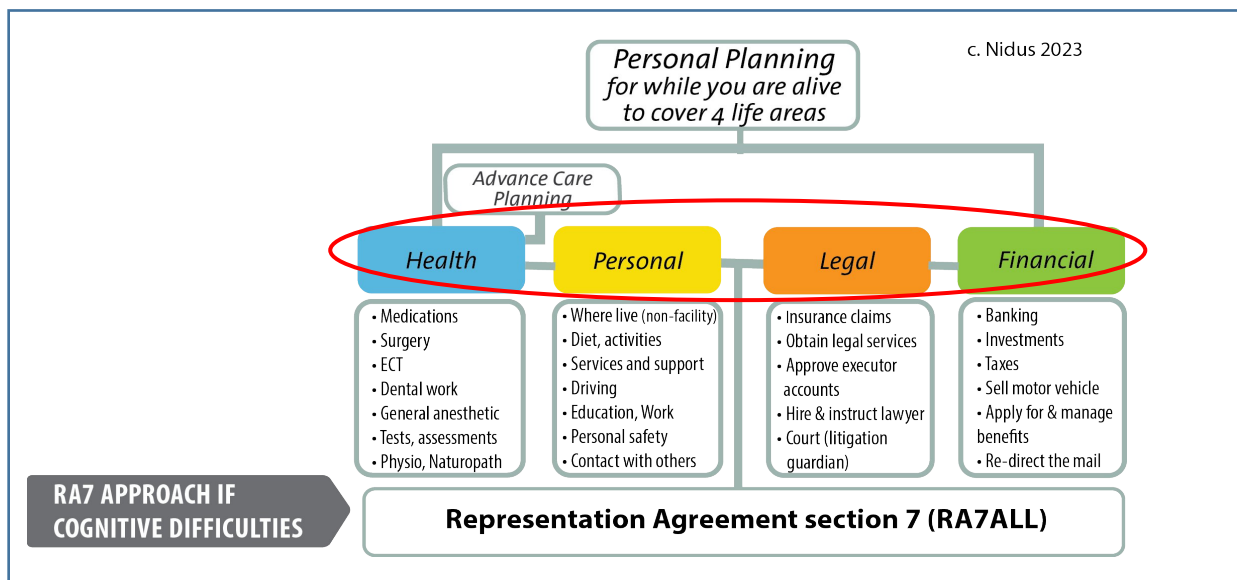
You will need a printer and access to the Internet to make this RA. See next page for some tips.

Do you have the right package?

The RA7ALL form has **all 4 authorities** outlined in [section 7 of the RA Act](#):

1. Minor and major **health care** matters,
2. **Personal care** matters including consent to certain living arrangements,
3. Obtain **legal** services and instruct counsel, and
4. Routine management of **financial** affairs.

The RA7ALL is designed for adults (19+) with cognitive difficulties.



RA7 is sometimes used as a generic term. Nidus uses more specific terms and has different forms. For other types of Representation Agreements like RA7H+P (health care and personal care only) or RA7F+L (routine financial affairs and legal matters only) go to <https://nidus.ca/ra-forms/>.

I'm not good with technology, how do I manage?

Ask relatives, friends, or personal supporters. Your local seniors' centre or library could also help, or they might provide some digital literacy workshops.

R GET ON TRACK

In the past it was common to ignore adults with cognitive difficulties or treat them like children. Today, we know better, and view all adults as capable of self-determination regardless of disability. The RA7 is a legal tool to enable that self-determination – it provides a legal appointee to support and help the adult access their rights.

The adult should try to sign their own Representation Agreement – signing is a physical action. Sometimes you need to modify the pen, so it is easier to grasp, or place the pen in their mouth and hold the paper up for them on a firm board/book. In law, a signature is a mark – the adult can make a line, squiggle, or other type of mark.
